1. Political family and Political dynasty

[Definition]

☐ Political family

"A political family consists of a family where more than one family member gains elected political positions in a particular geographic unit" (Aspinall & Uhaib As'ad 2016: 422).

* Elected political positions in Indonesia:

[At the national level]

- President, Vice President
- Members of Parliament (DPR)
- Members of Regional
 Representative Council (DPD)

[At the local level]

- Governor, Deputy Governor
- District Head (Bupati), Deputy District Head
- Mayor, Deputy Mayor
- Provincial, District, and City Legislators (DPRD)

□ Political family

"A political family consists of a family where more than one <u>family</u> <u>member gains elected political positions</u> in a particular geographic unit" (Aspinall & Uhaib As'ad 2016: 422).

* In this presentation, a political family includes a spouse and relatives up to the third degree of kinship, including both blood relatives and relatives by marriage.

☐ Political dynasty

- "A political family becomes a political dynasty only when it is able to extend its power temporally, so that **once the dynasty's founder loses office, he or she is succeeded by a family member**" (Aspinall & Uhaib As'ad 2016: 422).

Intra-generational succession (e.g. a spouse or sibling)
Inter-generational succession (e.g. a child or son/daughter-in-law)

c.f. Political dynasty in the Philippines

- "Traditional political families or the practices by these political families of monopolizing political power and public offices from generation to generation and treating the public elective officers almost as their personal property" (Park 2008: 120).

- A relatively short history of political families and dynasties
 (since democratization)
 c.f. The Philippine case
- Political families and dynasties at the provincial and district levels
- Horizontal spread of the power of political families
 e.g.,

[Only at the district level] ← Majority of political families

Members of a political family occupy a position of district head, a district legislative seat, and a local bureaucratic position in a single district.

[At the provincial and district levels]

Members of a political family occupy some political positions <u>in a single province</u>, such as governor, district head, and seats in district, provincial and national legislatures.

- Factors shaping the rise and features of political families and dynasties in Indonesia → Colonial policy, democratization, electoral system, the weaknesses of political parties, etc.
- The dominance of political families, oligarchic politics
- Use of violence in some cases
- Rent-seeking and patronage
- Money politics
- Accusations of corruption, civil society campaigns
 - → Difficulties in making the transition from political families to political dynasties

 Members of <u>Parliament (DPR)</u> and DPD

- Who is the most influential figure in local politics?
 - → Political families are sometimes backed by influential local patrons.

At the national level

- ☐ President & Vice President (maximum two 5-year terms)
- DPR: Dewan Perwakilan Rakyat Republik Indonesia (People's Representative Council) (no term limit)
- DPD: Dewan Perwakilan Daerah (Regional Representative Council) (no term limit)

At the local level

38 provinces, 416 districts, 98 cities

- ☐ Governors, District Heads, Mayors, and Deputies (maximum two 5-year terms)
- DPRD Provinsi: Provincial Representative Council (no term limit)
- DPRD Kabupaten/Kota: District/City Representative Council (no term limit)

Once a five years

Presidential Election

- Direct election
- Presidential election has been held on the same day as the general elections since 2019.

General Elections

- Members of DPR, DPD, DPRD
- Open list proportional representation system for the DPR and DPRD elections

Elections for Local Government Heads

- Governor, Mayor, District Head, and Deputies
- Direct election
- Unified nationwide local elections have been implemented since 2024.




Among the 580 DPR members, at least 121 have a family member who has held or currently holds a political position.

The number of the 2024-2029 DPR members whose family member has held or currently holds a political position such as..




5 families of ministers and party leaders have more than two family members who have held or currently hold political positions, and at least one is a DPR member.

Among the 580 DPR members, at least 41 can be regarded a member of **political dynasty**.

Succession to the position of _____ within or across generations





Among **37 Governors**, at least 12 (the pink provinces on the map) have a family member who has held or currently holds a political position.


Among **37 Deputy Governors**, at least 9 (the yellow provinces on the map) have a family member who has held or currently holds a political position.



Among 37 Governors, at least 13 have a family member who has held or currently holds a political position.



Among 37 Deputy Governors, at least 9 have a family member who has held or currently holds a political position.



Among the 74 Governors and Deputy Governors, at least 10 can be regarded a member of a political dynasty.


Different types of political families:

- A family of President whose power base lies in a leading position within
 a political party * Except for the Jokowi family
- A family of a minister and a party leader whose family members hold political positions at the both national and local levels
- A family of a local government head (Governor, District Head, or Mayor) who uses the position of a DPR or DPD member as a political resource to expand its political power at the local level
- A family of Governor whose power base lies in a district and includes a DPR or DPD member
- A family of Deputy Governor whose power base lies at both the provincial and district levels, and includes a DPR or DPD member

6. Discussion and Conclusion

Regional distribution of political families

- Powerful political families—holding political positions at the national, provincial, and district/city levels—are concentrated in some provinces, particularly North Sumatra, Banten, Central Kalimantan, and West Sulawesi.
